# From the Principal

## Welcome To Term 3

We are the lucky ones to be able to return to face-to-face teaching this term, when so many others may not be. So that we remain COVID safe, the strict routines and hygiene requirements we put in place at the end of last term will continue until further notice. Additionally, **we ask that students do not bring any toys or treasures to school.** This will help minimise the transfer risk. There are ample resources at school for play and sport so there is no need for students to bring things from home. Students who do bring items will be told to leave them in their school bag.

Some of you may be aware that Mrs DePasquale has been unwell recently. In order to properly recover and recuperate, Mrs D will not be returning this term. We wish her and her family all the best.

## Sovereign Hill Camp

This camp is now likely to go ahead in October, if there are adequate numbers from across the four schools involved and if there are no further COVID-19 restrictions before then that affect us. We understand that such short notice may have an impact on the affordability of this camp for some families. At this stage the overall cost for the camp is about \$250 per student. This is for a three day, two night camp and includes meals and some of the activities available. As always, we are able to offer families a payment plan arrangement, but given the time frame, this would be a reasonably short schedule as we need to allow for payment deadlines imposed by the camp itself. Please contact the office as soon as possible if you wish to set up a payment arrangement. Mica is available on Tuesdays and Thursdays or you can contact via the school email.

## NCCD – Nationally Consistent Collection of Data

Every year, all schools in Australia participate in the Nationally Consistent Collection of Data on School Students with Disability (NCCD). The NCCD process requires schools to identify information already available in the school about supports provided to students with disability. Included in this newsletter is a letter to families outlining what is involved and what it means for your children and yourselves.

## Family Stress

The global coronavirus pandemic has certainly played its part in exacerbating family and household tensions and issues. But I am also aware that COVID-19 is just one more thing to deal with and there are families that need help with a range of other matters. The Victorian Government now fully subsidises the TripleP – Positive Parenting Program. Often, managing children at home in times of stress or just everyday life, can add to pressures. This program comes highly recommended and provides families and individuals with strategies and skills they never knew they had! Take a look at what this free program can offer you!

Families can now access free expert parenting advice through the online [Triple P – Positive Parenting Program](#).

The program is relevant to families with children between 2 and 16 years and provides strategies to deal with specific challenges, such as building children's resilience and dealing with conflict. There are courses specifically for parents of toddlers to tweens, and for parents of pre-teens to teens.

### **It gives parents strategies to:**

- raise happy, confident kids
- manage misbehaviour so everyone in the family enjoys life more
- set rules and routines that everyone respects and follows
- encourage positive behaviour
- take care of themselves as a parent
- feel confident they're doing the right thing.

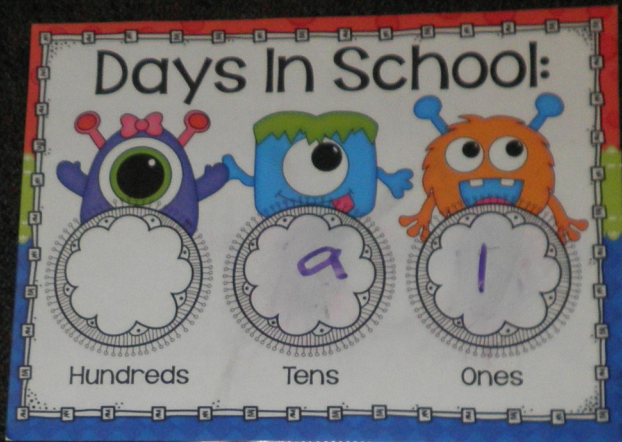

**Re: Nationally Consistent Collection of Data on School Students with Disability (NCCD)**

Every year, all schools in Australia participate in the Nationally Consistent Collection of Data on School Students with Disability (NCCD). The NCCD process requires schools to identify information already available in the school about supports provided to students with disability. These relate to legislative requirements under the *Disability Discrimination Act 1992* and the Disability Standards for Education 2005, in line with the *NCCD guidelines (2019)*.

Information provided about students to the Australian Government for the NCCD includes:

- year of schooling
- category of disability: physical, cognitive, sensory or social/emotional
- level of adjustment provided: support provided within quality differentiated teaching practice, supplementary, substantial or extensive.

This information assists schools to:

- formally recognise the supports and adjustments provided to students with disability in schools
- consider how they can strengthen the support of students with disability in schools
- develop shared practices so that they can review their learning programs in order to improve educational outcomes for students with disability.

The NCCD provides state and federal governments with the information they need to plan more broadly for the support of students with disability.

The NCCD will have no direct impact on your child and your child will not be involved in any testing process. The school will provide data to the Australian Government in such a way that no individual student will be able to be identified – the privacy and confidentiality of all students is ensured. All information is protected by privacy laws that regulate the collection, storage and disclosure of personal information.
